BetterBusiness focuses on the need for very small businesses and SMEs to benefit from practical, tailor-made support that takes account of their size, sector and often limited resources.

Forum Ethibel audits BetterBusiness's implementation of the rules written out in the Terms of Reference (*Cahier des charges*) updated on 21/08/2025. This is an internal document whose purpose is to explain the founding principles and operations of the ShiftingPact certification, and to explain the various stages of the process, from the initial assessment to recertification. The Terms of Reference also describe specifically the sections that are covered by this audit. The sections out-of-scope are referenced at the end of this report as well. A simplified version of the Terms of Reference will be available to the public on the ShiftingPact website in the coming months.

Forum Ethibel had BetterBusiness's full administrative cooperation for the audit work. All additional information requested was provided. This report concerns all organisations screened for the ShiftingPact Label awarding in July 2026. This concerns the initial certification of 4 companies out of which 4 are compliant with the label, and the recertification of 1 company, out of which 1 remains compliant with the label.

I. AUDIT PROCESS

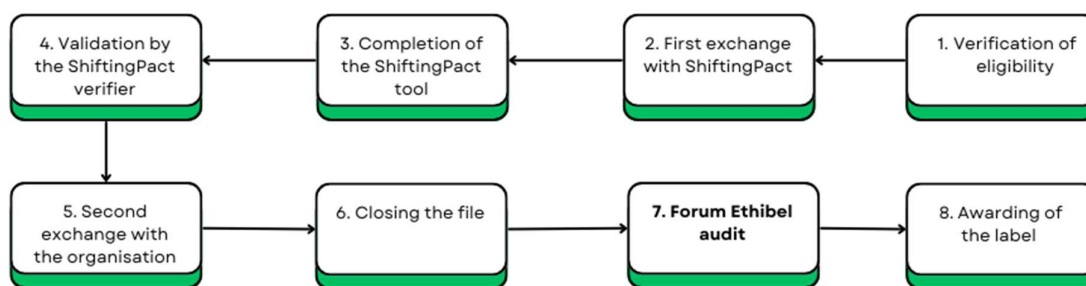
Certification

The process started by predetermining the scope of the audit. All steps leading to the awarding of the label and the continuous improvement process of the label are in scope of the audit. All other parts of the Terms of Reference are not covered by this report. The process of improvement and the engagement follow-up will be assessed quarterly.

Continuous dialogue took place between BetterBusiness and Forum Ethibel to assess the conformity of the verification process on ready-to-be-labelled enterprises.

For all screenings performed by BetterBusiness in July 2026, Forum Ethibel gathers its conclusions in one unique audit report. This audit is performed **ex-ante**.

For all enterprises, Forum Ethibel assessed if BetterBusiness went through all the steps described in the Terms of Reference by reviewing the filled-in questionnaires and BetterBusiness's assessment. In general, Forum Ethibel also audits whether the rules of the Terms of Reference were implemented for each label batch with consistency for all enterprises of a verification batch, with an emphasis on data gathering, the motivation to give or cancel points, adherence to the overarching philosophy of the label and conflict of interest management. Below, the figure presents a visual representation of the ShiftingPact labelling process, highlighting the timing of the audit conducted by Forum Ethibel.



Recertification

As regards recertification, which takes place every two years, the process is similar and follows steps 3 to 8 in the diagram above. Forum Ethibel is responsible for auditing compliance with the procedures in the same way as for the initial label awarding. The auditing process therefore follows a similar structure.

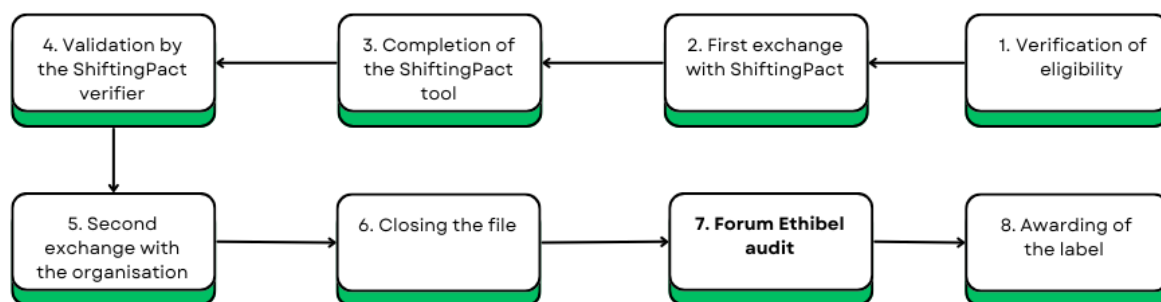

COMMITMENT MONITORING

The Terms of References stipulates that BetterBusiness shall monitor the progress of companies' implementation of their commitments every six months as part of the certification process.

The auditor notes that carrying out three follow-up audits between certification and recertification does not appear to be practically feasible at present, particularly given the response times of organisations.

In light of this, particular attention is paid to ensuring that companies hold at least one follow-up meeting with BetterBusiness. At present, 62% of companies have had at least one meeting or have one scheduled, amongst those that are expected to do so. This represents a catch-up effort compared with the situation observed in December 2025, but at a more moderate pace since the last review in April 2026.

BetterBusiness is also committed to organise a quarterly webinar focusing on strategies for improvement in both environmental and social areas. A conference on renewable energy was organised in collaboration with RaYSun et Neo&Nea on 12 May.

RECOMMENDATIONS

Forum Ethibel proposes the following recommendations for enhancing the ShiftingPact verification process as part of the continuous improvement philosophy shared by BetterBusiness and Forum Ethibel. These recommendations aim at strengthening the audit of the verification and the credibility of the approach.

- Company responses should be supported, where possible, by written documentation. All documents used in the assessment process should be securely stored to maintain data integrity and facilitate future audits.
- When documentary evidence is not required, it is advisable to specify how the company meets the ESG criterion where it can be met in different ways. This is important to ensure equal treatment of companies among each other and over time, as well as to provide a complete view of the verification for audit purposes.
- It is recommended that ShiftingPact further populate the SDG module rating guidelines available to Forum Ethibel, drawing on the experience gained since the launch of the label.
- Given the current difficulty in contacting organisations to carry out three follow-ups on commitments during a recertification period, the auditor recommends either amending the Terms of Reference or changing the processes so as to align practices with policies.
- BetterBusiness may, on occasion, provide services to certified organisations (such as carbon assessments or B Corp support) where the outcome helps the company to fulfil their commitments and meet the label's criteria, between certification and recertification. As these situations present potential conflicts of interest, Forum Ethibel recommends establishing specific guidelines for such situations as a precautionary measure.

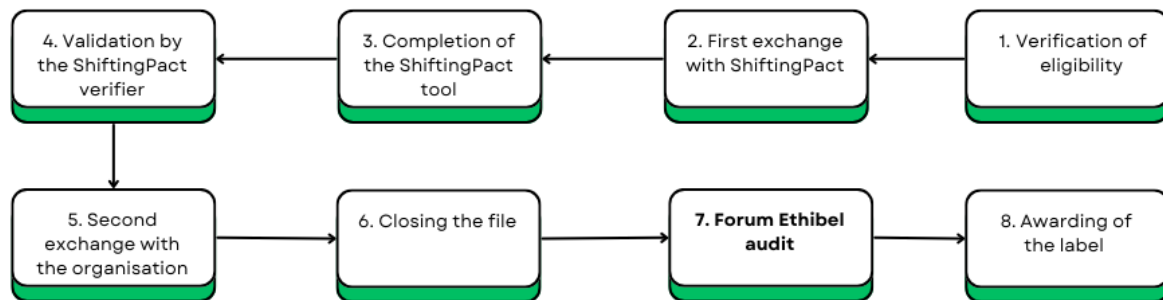

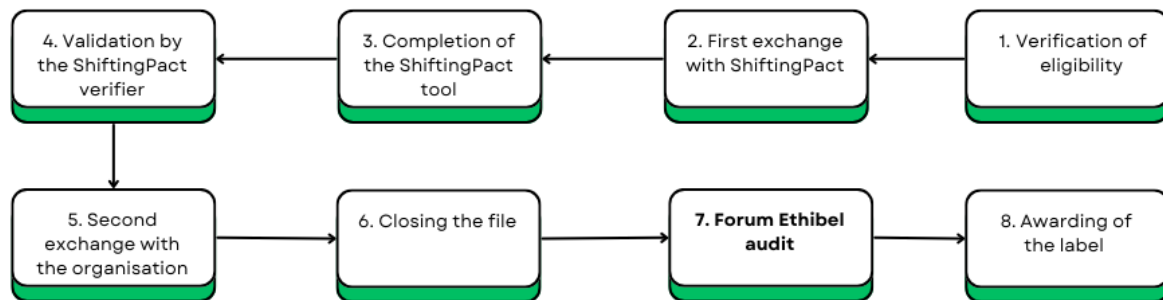

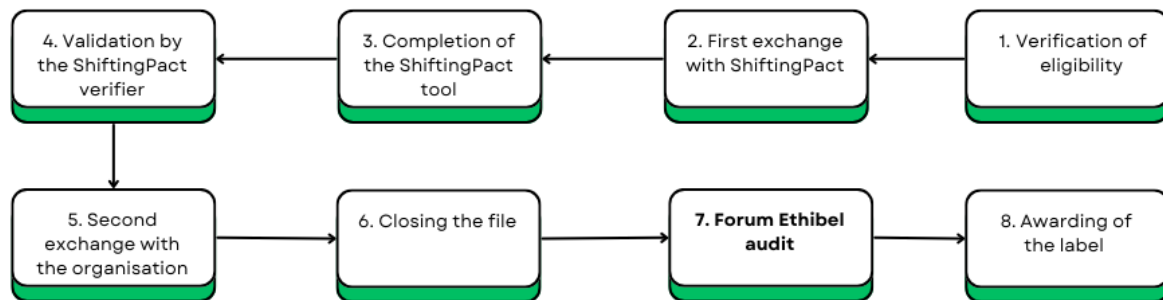

COMMITMENT MONITORING

The Terms of References stipulates that BetterBusiness shall monitor the progress of companies' implementation of their commitments every six months as part of the certification process. Forum Ethibel notes that BetterBusiness is making efforts to catch up on the delay observed in December 2025. At present, 50% of the expected follow-up interviews have been conducted or have a scheduled date, compared with around 30% four months ago. All companies have been contacted.

BetterBusiness is also committed to organising a quarterly webinar focusing on strategies for improvement in both environmental and social areas. A conference on financing sustainability was organised in collaboration with the Brussels Region on 10 March.

RECOMMENDATIONS

Forum Ethibel proposes the following recommendations for enhancing the ShiftingPact verification process as part of the continuous improvement philosophy shared by BetterBusiness and Forum Ethibel. These recommendations aim at strengthening the audit of the verification and the credibility of the approach.

- Company responses should be supported, where possible, by written documentation. All documents used in the assessment process should be securely stored to maintain data integrity and facilitate future audits. ShiftingPact has been making efforts in this direction over the past two months, and Forum Ethibel encourages them to pursue this work.
- When documentary evidence is not required, it is advisable to specify how the company meets the ESG criterion where it can be met in different ways. This is important to ensure equal treatment of companies among each other and over time, as well as to provide a complete view of the verification for audit purposes.
- It is recommended that ShiftingPact further populate the SDG module rating guidelines available to Forum Ethibel, drawing on the experience gained since the launch of the label.

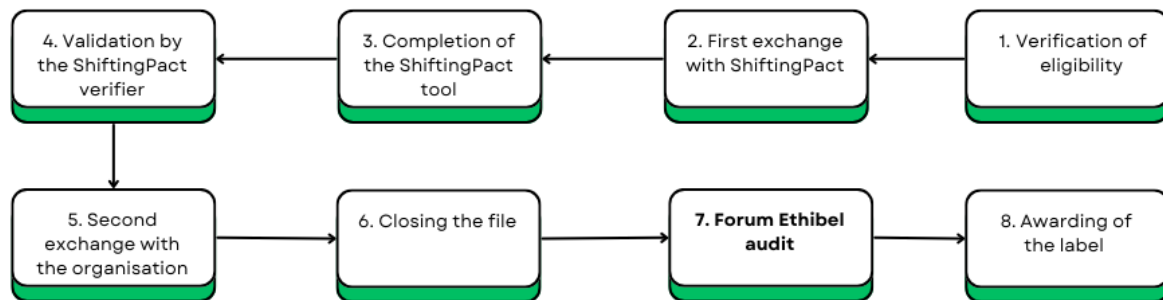

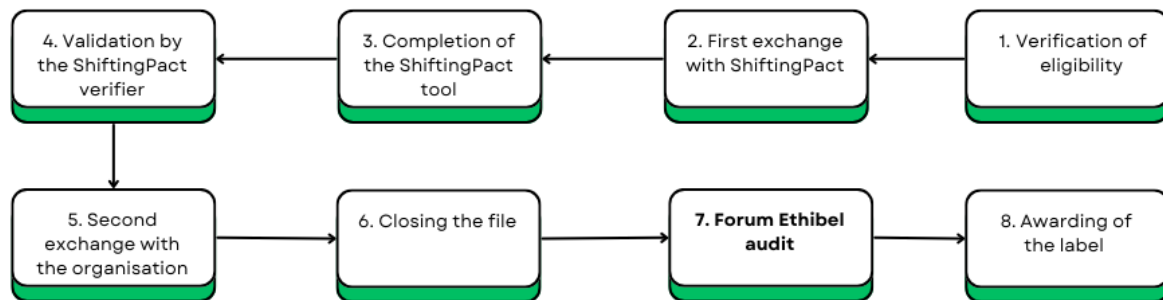

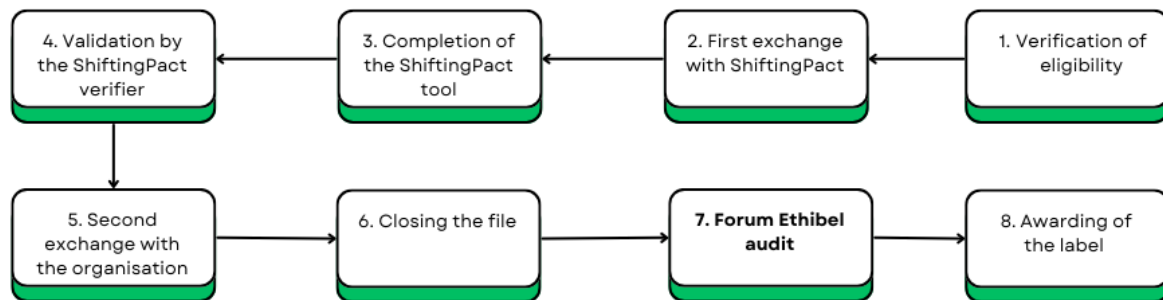

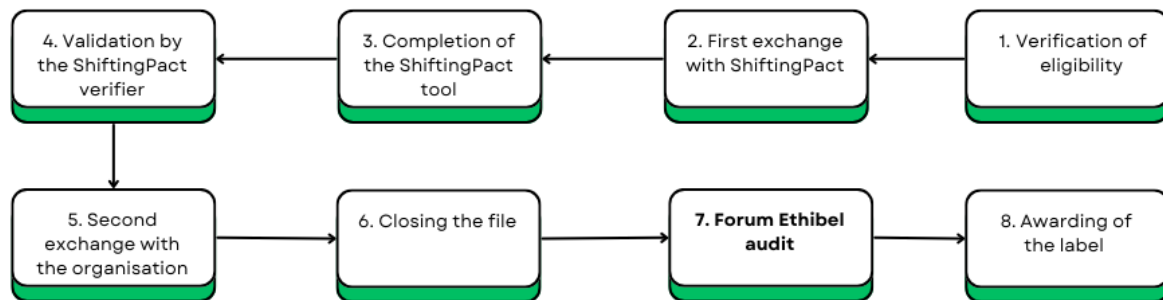

For all screenings performed by BetterBusiness in November 2025, Forum Ethibel gathers its conclusions in one unique audit report. This audit is performed **ex-ante**.

For all enterprises, Forum Ethibel assessed if BetterBusiness went through all the steps described in the Terms of Reference by reviewing the filled-in questionnaires and BetterBusiness's assessment. 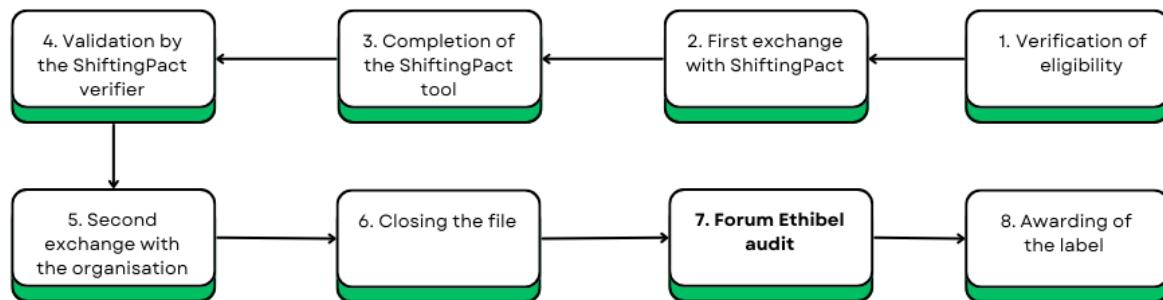

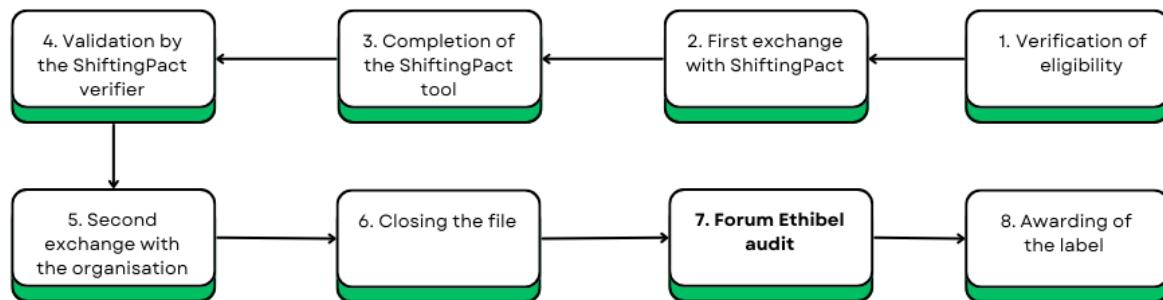

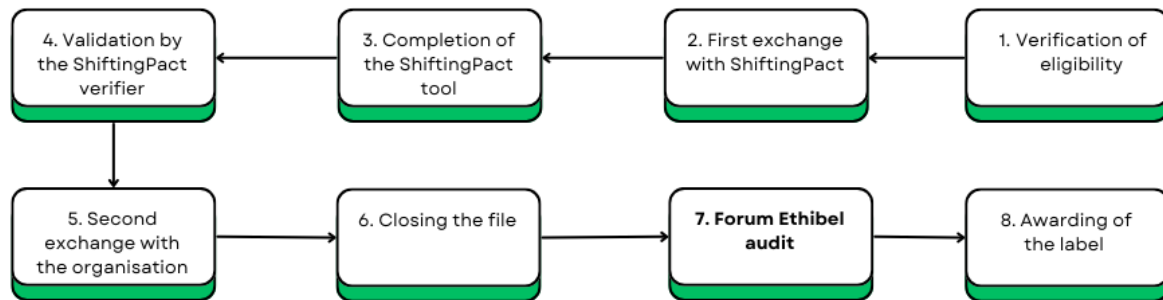

BetterBusiness focuses on the need for very small businesses and SMEs to benefit from practical, tailor-made support that takes account of their size, sector and often limited resources.

Forum Ethibel audits BetterBusiness's implementation of the rules written out in the Terms of Reference (*Cahier des charges*) updated on 09/06/2025. This is an internal document whose purpose is to explain the founding principles and operations of the ShiftingPact certification, and to explain the various stages of the process, from the initial assessment to recertification. The Terms of Reference also describe specifically the sections that are covered by this audit. The sections out-of-scope are referenced at the end of this report as well. A simplified version of the Terms of Reference is available upon request to ShiftingPact.

Forum Ethibel had BetterBusiness's full administrative cooperation for the audit work. All additional information requested was provided. This report concerns all organisations screened for the ShiftingPact Label awarding in June 2025. This concerns 17 companies out of which 17 got the label.

I. AUDIT PROCESS

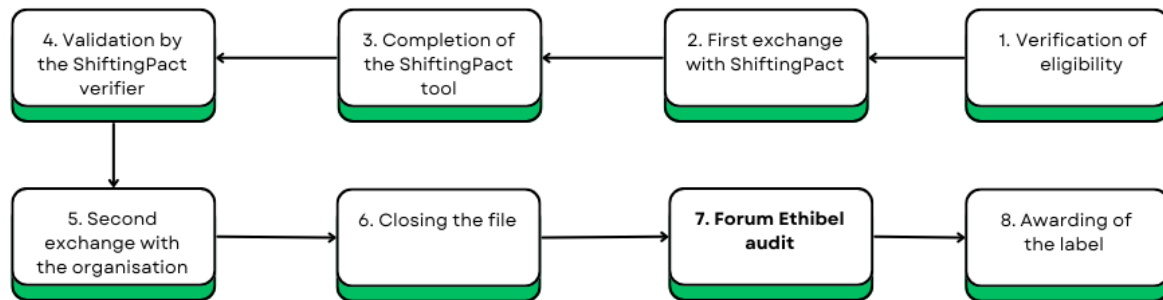
The process started by predetermining the scope of the audit. All steps leading to the awarding of the label and the continuous improvement process of the label are in scope of the audit. All other parts of the Terms of Reference are not covered by this report. The process of improvement and the engagement follow-up will be assessed quarterly.

Continuous dialogue took place between BetterBusiness and Forum Ethibel to assess the conformity of the verification process on ready-to-be-labelled enterprises.

For all screenings performed by BetterBusiness in July 2025, Forum Ethibel gathers its conclusions in one unique audit report. This audit is performed **ex-ante**.

For all enterprises, Forum Ethibel assessed if BetterBusiness went through all the steps described in the Terms of Reference by reviewing the filled-in questionnaires and BetterBusiness's assessment. In general, Forum Ethibel also audits whether the rules of the Terms of Reference were implemented for each label batch with consistency for all enterprises of a verification batch, with an emphasis on data gathering, the motivation to give or cancel points, adherence to the overarching

philosophy of the label and conflict of interest management. Below, the figure presents a visual representation of the ShiftingPact labelling process, highlighting the timing of the audit conducted by Forum Ethibel.

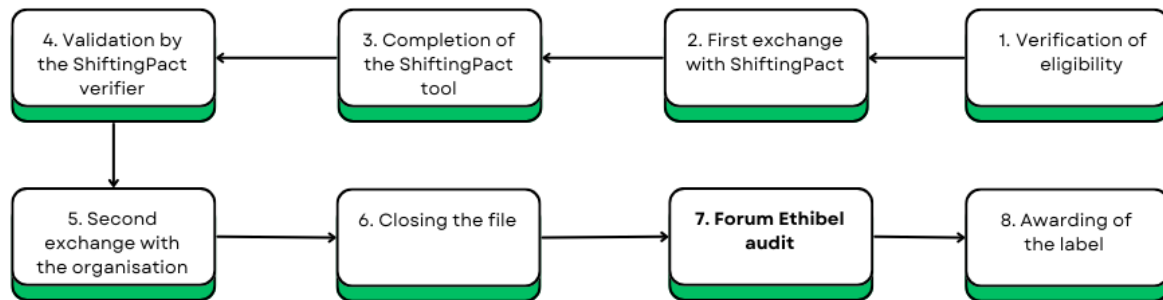

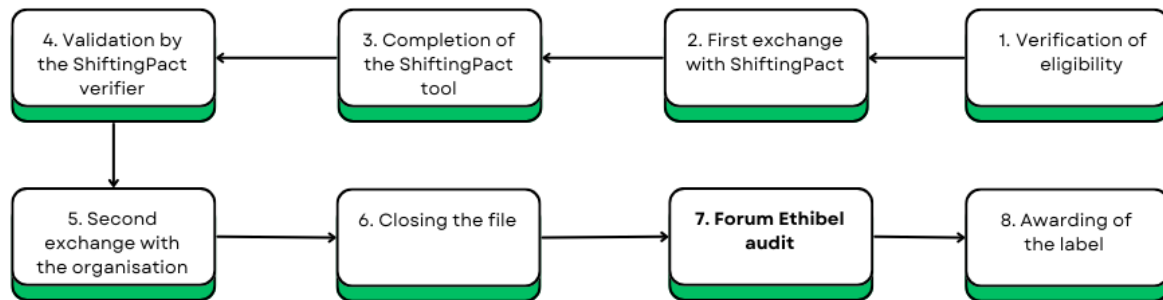

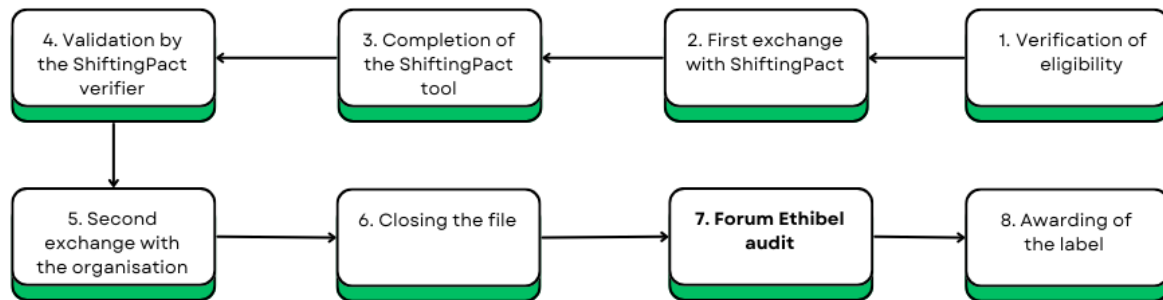

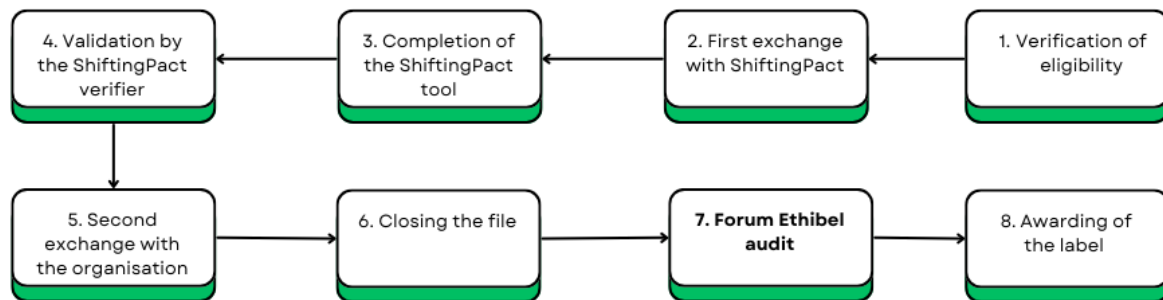

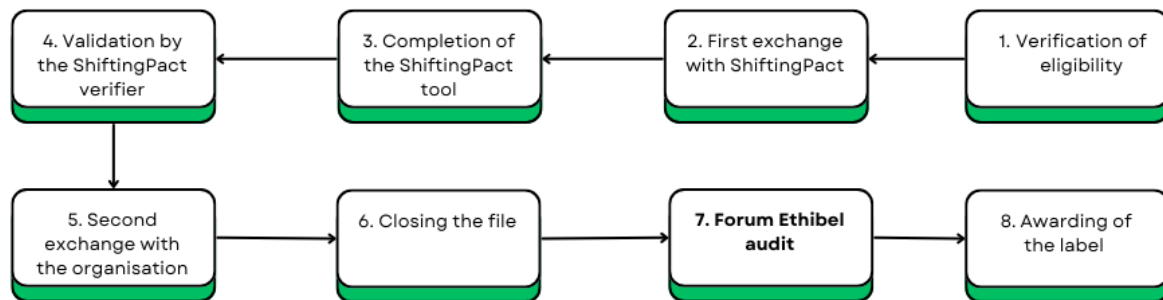

- The Better Business verification methodology underwent several adjustments prior to the January 2025 batch, as is natural during the launch period and in a spirit of continuous improvement. However, it is strongly recommended that all modifications be systematically documented and justified, so as to have a clear view of how each batch was verified and the reasons for the change. Any

point correction by Shifting Pact should be clearly justified, providing a rationale for each change to enhance transparency and ensure alignment with regulatory or internal standards.

- It is recommended that the engagements be described in greater detail (KPIs, implementation methods, etc.), so that an objective assessment of their implementation can be made at the time of recertification.
- An independent committee must be set up to deal with any disagreements. This is already the ambition of BetterBusiness. It is also advisable that the company can initiate a disagreement procedure directly with this committee.

The screening performed by Forum Ethibel guarantees that the procedure of BetterBusiness concerning the ShiftingPact Label is observed and applied as communicated.

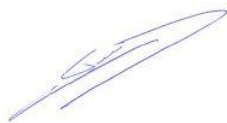
CONCLUSION

All documents to assess the processes for all organisations screened in 2024 were provided.

Therefore, we declare that, for 2024, the screening of organisations with the aim of receiving the ShiftingPact Label was in compliance with the processes described in the White Paper and in scope of this audit with the exception of:

- For 5 companies in the batch, the documents received do not allow us to confirm the questionnaire has been completed by the company. However, the auditor saw no evidence that the questionnaires were not completed by the company.
- For 17 companies in the batch, the documents we have received do not allow us to confirm that the verification meetings took place. However, the auditor saw no evidence that the verification meetings did not take place.
- Insofar as these are the first label-awardings and took place before the publication of the ShiftingPact White Paper, on the draft of which Forum Ethibel based its audit, several points are considered not yet applicable in the context of this audit:
 - o The storage of supporting documents
 - o The integration of minimum commitments
 - o The procedure for identifying and dealing with conflicts of interest.

In conclusion, the auditor noted several inconsistencies in the verification of the ShiftingPact label for companies screened in 2024, but none of the inaccuracies put companies at significant risk of being wrongfully awarded the ShiftingPact label.

Forum Ethibel is appointed by BetterBusiness to execute an external audit of their verification process on the awarding of the ShiftingPact Label.

BetterBusiness is a B Corp company whose mission is to help companies to create, develop and implement their sustainability strategy. BetterBusiness focuses on the need for SMEs to benefit from practical, tailor-made support that takes account of their size, sector and often limited resources.

However, in the specific case of the 2024 audit concerning the very first files audited by Better Business, the White Paper was in the process of being written, and a draft was distributed to Forum Ethibel. Insofar as the audit methodology was still being finalised, several elements of the white paper published in January 2025 do not apply to 2024.. The sections out-of-scope are referenced at the end of this report.

Forum Ethibel had BetterBusiness's full administrative cooperation for the audit work. All additional information requested was provided. This report concerns all organisations screened for the ShiftingPact Label awarding in January 2024. This concerns 38 companies out of which 37 got the label.

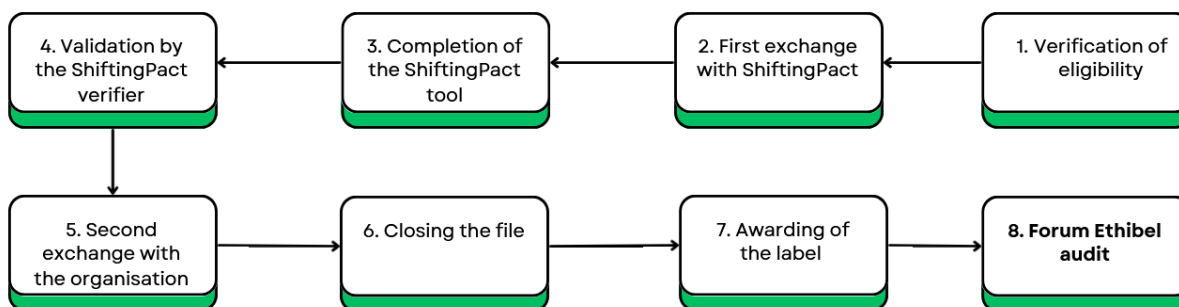
I. AUDIT PROCESS

The process started by predetermining the scope of the audit. It was agreed on that all steps leading to the awarding of the label and the continuous improvement process of the label were in scope of the audit. The process of improvement and the engagement follow-up will be assessed quarterly, starting at the end of the first quarter.

Continuous dialogue took place between BetterBusiness and Forum Ethibel to assess the conformity of the verification process on ready-to-be-labelled enterprises.

For all screenings performed by BetterBusiness in 2024, Forum Ethibel gathers its conclusions in one unique audit report. This audit is performed ex-post.

For all enterprises, Forum Ethibel assessed if BetterBusiness went through all the steps of the verification process by reviewing the filled-in questionnaires and BetterBusiness's assessment. In general, Forum Ethibel also audits whether the rules of the verification process were implemented for each label batch with consistency for all enterprises of a verification batch, with an emphasis on data gathering, the motivation to give or cancel points, adherence to the overarching philosophy of the label and conflict of interest management. Below, the figure presents a visual representation of the ShiftingPact labelling process, highlighting the timing of the audit conducted by Forum Ethibel.



II. ASSESSMENT

The observations below discuss the findings of the audit. A detailed overview of Forum Ethibel's audit of each of the White Paper's points is given in the accompanying table.

Observations:

- For 5 companies, the verification template did not allow us to distinguish between the company's answers and the corrections subsequently made by BetterBusiness. In such cases, we indicated the point “assessment completed by the company” as unverified in the overview below.
- In the same way, meetings for which the verifier has not received a screenshot from the agenda are noted as unverified in the overview below.
- For 3 companies, the section on additional commitments is considered not applicable. This is due to the fact that they have either not made any additional commitments , or have failed to obtain the label and therefore do not have a Commitment Pact either.

Insofar as these are the first label-awardings and took place before the publication of the ShiftingPact White Paper, several points are not yet applicable in the context of this audit:

- The storage of supporting documents
- The integration of minimum commitments
- The procedure for identifying and dealing with conflicts of interest.

In conclusion, the auditor noticed several inconsistencies in the verification of the ShiftingPact label for companies screened in 2024, but none of the mistakes put companies at risk of being wrongfully awarded the ShiftingPact label.

Recommendations

Forum Ethibel proposes the following recommendations for enhancing the ShiftingPact verification process as part of the continuous improvement philosophy shared by BetterBusiness and Forum Ethibel. These recommendations aim at strengthening the audit of the verification and the credibility of the approach. It should be noted that since batch 2024 was audited in March 2025, the auditor has already noted numerous improvements relating to their observations.

- Company responses should be supported, where possible, by written documentation. All documents used in the assessment process should be securely stored to maintain data integrity and facilitate future audits.
- An independent committee must be set up to deal with any disagreement. This is already the ambition of BetterBusiness. It is also advisable that the company can initiate a disagreement procedure directly with this committee.
- The auditor recommends elaborating on the guidelines stated in the referential White paper for 2025.
